1. WHAT INFORMATION DO WE COLLECT?

Personal information you disclose to us

In short, we collect personal information that you voluntarily provide to us.

This includes information provided when you register, express interest in our services, participate in activities, or contact us.

Personal information may include:

- Names
- Phone numbers
- Email addresses
- Mailing addresses
- Job titles
- Usernames
- Passwords

- Contact preferences
- Billing addresses
- Debit or credit card details
- Health information
- Medical information

Sensitive information

With your consent or where permitted by law, we may process sensitive information such as health and medical data.

Payment data

Payments are processed by Stripe Inc and Trainerize. We do not store payment card details.

Application data

If you use our applications, we may collect:

- Mobile device data such as device ID, operating system, and IP address
- Usage data for analytics and troubleshooting
- Push notification preferences

Information automatically collected

In short, some information such as IP address and device characteristics is collected automatically.

This includes:

- Log and usage data
- Device data
- Location data
- Cookie and tracking data

This information supports security, analytics, and service improvement.

2. HOW DO WE PROCESS YOUR INFORMATION?

In short, we process information to provide and improve services, communicate with you, prevent fraud, and comply with legal obligations.

This includes processing for:

- Account creation and management
 - Service delivery
 - Customer support
 - Administrative communications
 - Marketing communications
 - Service improvement and analytics
 - Legal compliance

--- 3. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION? ---

In short, we may share information in specific situations with trusted third parties.

These include:

- Advertising networks
- Analytics providers
- Data storage providers
- Payment processors
- Sales and marketing tools

We may also share information during business transfers or with business partners.

--- 4. DO WE USE COOKIES AND TRACKING TECHNOLOGIES? ---

In short, yes.

We use cookies, pixels, and similar technologies for security, analytics, and advertising.

Google Analytics may be used, including remarketing and demographics reporting. You can opt out via <https://tools.google.com/dlpage/gaoptout>.

--- 5. HOW LONG DO WE KEEP YOUR INFORMATION? ---

In short, we keep information only as long as necessary.

Personal information is retained for no longer than 12 months after an account becomes inactive, unless required by law.

--- 6. HOW DO WE KEEP YOUR INFORMATION SAFE? ---

We use reasonable technical and organisational safeguards. However, no system can be guaranteed fully secure.

7. DO WE COLLECT INFORMATION FROM MINORS?

We do not knowingly collect information from individuals under 18 years of age.

8. WHAT ARE YOUR PRIVACY RIGHTS?
